RESIDENTIAL SERVICE PLAN

The plan starts with a thorough inspection of your home to identify problem areas and potential problem areas. The emphasis is on inspection, minimal chemical control and prompt quality service. Treatments are done on an as needed or as requested basis during normal business hours. Pest monitors will be setup in appropriate areas. During the spring and summer months, you will receive two (2) unscheduled exterior treatments to help prevent any infestation. There will be no additional charge for treatment during the plan for the pests listed below.

The plan includes treatment for the following pests: roaches, stored product pests, fabric pests, mice, rats, silverfish, firebrats, ticks and fleas (inside), pill bugs, sow bugs, centipedes, millipedes, crickets, wasp and bee nests (except honey bees), carpenter bees, ants and spiders.

Specifically NOT included are treatments for termites, bed bugs, carpenter ants, honey bees, wildlife and birds, however inspections for these pests and others are included, if necessary.

This plan, at its conclusion, can be renewed. The owner will be notified prior to the expiration date. Either party may terminate the plan only at the end of a period.

The customer is responsible for the following: Repair any leaks in the plumbing, roof, windows, etc. Caulk window and door frames. Keep gutters clean and in good repair. Keep soil from touching or covering house siding. Keep trees and shrubbery cut back away from the house. Keep woodpiles as far from the house as practical.

Results of services rendered are strictly relative to and dependent upon cooperation given by the customer as to sanitary conditions, maintenance, accessibility of the building and/or prompt reporting of pest sightings by the customer. The customer agrees to cooperate with Advantage in whatever reasonable manner is necessary to facilitate treatment and elimination. If the customer does not cooperate service may continue, but results cannot be assured.
